I agree to conduct myself according to biblical principles at all times. This means that I will refrain from any sexual misconduct, including, but not limited to, inappropriate or unwanted touching, premarital sex, homosexual activity, sexual harassment, use or viewing of pornographic material or websites, and other forms of sexually deviant behavior. I understand that such behaviors or deviations from Scripture are grounds for expulsion.
